Determination Order

Ref: DR0518-43425

In the matter of Leonard Kinsella [Applicant Landlord] and David James Coughlan [Respondent Tenant] the Residential Tenancies Board, in accordance with section 121 of the Residential Tenancies Act 2004, determines that:

1. The Notice of Termination served on the 22 March 2018 by the Applicant Landlord on the Respondent Tenant in respect of the tenancy of the dwelling at 303 Glenlara, Mount Kellett, Dock Road, Co. Limerick is valid.
2. The Respondent Tenant and any other person residing in the above dwelling should vacate and give up possession of the above dwelling within fourteen days of the date of issue of this Order.
3. The respondent tenant shall pay any further rent at the current rate of €450.00 per monthly rental period or proportional part thereof at the rate of €14.79 per day and any other charges as set out in the terms of the tenancy agreement for each week or part thereof, until such time as the dwelling is vacated.
4. The Respondent Tenant shall pay the total sum of € 8,681.43 to the applicant landlord, in 11 equal instalments at the rate of €750.00 per calendar month, on the 1st of each month, followed by one further instalment of €431.43 in the immediately succeeding month commencing the next month after the issue of this Order. This sum represents rent arrears of €8,481.43 together with the sum of €200.00 awarded in respect of damages.
5. The enforcement of this Order for such payment of €8,681.43 will be deferred and the total sum owing reduced by the cumulative sum paid in the monthly instalments of €750.00 or €431.43 with respect to the twelfth and final instalment made by the Respondent Tenant to the Applicant Landlord on each due date until such time as the total sum of €8,681.43 has been paid in full.
6. For the avoidance of doubt, any default in the payment of any of the monthly instalments €750.00 or €431.43 with respect to the twelfth and final instalment shall act to cancel any further deferral and the balance due at the date of default of any such monthly payment shall immediately become due and owing to the Applicant Landlord.
7. The Applicant Landlord shall refund the entire of the security deposit of €450.00 to the Respondent Tenant, upon the Respondent Tenant vacating and giving up possession of the above dwelling, less any amounts properly withheld in accordance with the provisions of the Act.
