Determination Order

In the matter of Stephen Tennant, Applicant (Acting in capacity as receiver over certain assests of Robert Donald Burtenshaw, Landlord) [Applicant Receiver] and Danny O' Toole [Respondent Tenant] the Residential Tenancies Board, in accordance with section 121 of the Residential Tenancies Act 2004, determines that:

- 1. The Notice of Termination with a date of service of 25th September 2020 served by the Applicant Receiver on the Respondent Tenant in respect of the tenancy of the dwelling at 6 Barons Hall Lodge, Ballbriggan, Dublin K23W722 is valid.
- 2. The Respondent Tenant and any other person(s) residing in the above dwelling shall vacate and give up vacant possession of the above dwelling within 7 days of the date of issue of this Determination Order.
- 3. The Respondent Tenant shall pay the total sum of €20,000.00 to the Applicant Receiver, by way of 40 consecutive instalments at the rate of €500.00 per calendar month, on or before the 28th day of each month commencing the next month after the issue of this Determination Order. This sum represents rent arrears of €20,000.00, in respect of the tenancy of the dwelling at 6 Barons Hall Lodge, Ballbriggan, Dublin K23W722.
- 4. The Respondent Tenant shall also pay any further rent outstanding from 9th August 2021, being the date of the Adjudication Hearing, at the rate of €760.00 per month or proportionate part thereof at the rate of €25.33 per day, unless lawfully varied, and any other charges as provided for under the terms of the tenancy agreement for each month or part thereof, until such time as the above dwelling is vacated by the Respondent Tenant and any other persons residing therein.
- 5. The enforcement of this Determination Order for such payment of €20,000.00 will be deferred and the total sum owing will be reduced by the cumulative sum paid, in monthly instalments, by the Respondent Tenant to the Applicant Receiver, on each due date, until such time as the total sum of €20,000.00 has been paid in full.
- 6. For the avoidance of doubt, any default in the payment of any of the monthly/weekly instalments shall act to cancel any further deferral and the balance due at the date of default of any such monthly payment shall immediately become due and owing to the Applicant Receiver.
